

Other Fabrication Processes: Assembled float glass products can also take the form of insulated glass units, or IGUs. An IGU commonly consists of two or more lites of glass separated by a spacer material and sealed together at the edge. The insulating airspace can be filled with air, or a noble gas such as argon or krypton, to provide a thermal barrier. Another common example of a fabricated float glass product is a mirror (*i.e.*, flat glass coated with a silver, aluminum, or another reflective layer) with one or more LEDs integrated with the mirror, as well as framed mirrors with one or more LEDs integrated with the mirror or the mirror frame.

V. THE DOMESTIC INDUSTRY HAS BEEN MATERIALLY INJURED AND IS THREATENED WITH MATERIAL INJURY BY REASON OF UNFAIRLY TRADED SUBJECT IMPORTS

A. Legal Standard

The Commission must determine whether a domestic industry is materially injured or is threatened with material injury by reason of the dumped and/or subsidized imports.¹⁷ The statute defines “material injury” as “harm which is not inconsequential, immaterial, or unimportant.”¹⁸ The Commission examines the “significance” of the volume and price effects of the dumped and/or subsidized imports, and the impact of those imports on the condition of the domestic industry, when investigating if a domestic industry is materially injured or threatened with material injury “by reason of” dumped and/or subsidized imports.¹⁹ The Commission’s analysis must consider the prevailing conditions of competition in the U.S. market.²⁰
